**Freedom of Information request: FOI2022/00258**

Thank you for your Freedom of Information request received on the 8 August in which you requested the following:

**Your request:**

*I am looking for some data on women's participation in innovation projects.*

*Please could you provide the following information with regard to the Innovate UK Smart Grants and the competitions from the last three years to the January 2022 Competition:*

- 1. Total number of applications funded by year*
- 2. Number of applications involving a female partner irrespective of organisation type by year*
- 3. Number of applications involving a female lead business partner by year*
- 4. Number of applications involving a female academic partner by year*

*Could you also please provide the following information with regard to the Knowledge Transfer Partnerships and the competitions from the last three years to the 2021 to 2022, round 5:*

- 1. Total number of applications funded by year*
- 2. Number of applications involving a female partner irrespective of organisation type by year*
- 3. Number of applications involving a female lead business partner by year*
- 4. Number of applications involving a female academic partner by year*
- 5. Number of female KTP Associates by year*

**Our response**

I can confirm UK Research and Innovation (UKRI) hold some information relevant to your request. Please see the information in tables 1 and 2 below in relation to Innovate UK Smart Grants and Innovate UK Knowledge Transfer Partnerships (KTP).

UKRI does not hold information in the format requested and the tables are representative of the gender breakdown of the information we hold. Please note that the submission of gender data is voluntary.

The numbers provided are for all competitions that have closed and awards have been allocated, and includes data for the April 2022 Smart competition and KTP 2022 to 2023 round 2. Innovate UK started to routinely collect gender data in August 2020, therefore no data is available for earlier competitions. The survey has only collected responses from the lead applicant.

The survey asks for 'gender' and provides the response options of "female" "male" "prefer not to say" and "prefer to self-describe". "Non-binary" has been made into an additional category from 'prefer to self-describe' submissions. All survey responses have been provided to show a complete record.

To ensure anonymity of applicants, counts are rounded to the nearest multiple of 5. Counts and results are not disclosed for groups with 1 to 4 members, which are denoted with '--'. Where there are no applicants in a group, a count of zero would be included. Percentages shown are calculated on the unsuppressed counts. As a result some totals may not correspond with the data provided.

Innovate UK launched an updated EDI survey in May 2022, which aims to increase the response rate to the survey. The data provided is up to 18 August 2022 and includes some data from the updated survey, where applications were received beyond May 2022. In addition, Innovate UK has committed to annual publications of EDI data and expects to start publishing EDI data next year.
