please find attached an invitation to a workshop covering work we have done for the Knowledge Exchange project with IPO and also work being done by CREATE.

The workshop will take place on April 13 (CREATE) and 14th (Knowledge Exchange).

The workshop is outside the grant period for the Knowledge Exchange - it was not

possible to organise it before the end of the current semester at QMUL.

For this reason and due to the delays that arose through the dispute with IPO we would be grateful if ESRC were to agree to a no-cost extension of the grant period of 3 months. This would allow us to strengthen the data analysis before we report to ESRC on the grant.
