Thank you for your Freedom of Information request received on the 16 June in which you requested the following:

Your request:

I would like to request some information on the number and cost of the assessing applications submitted to Innovate UK.

Please would you provide me with the following covering the last 5 fiscal years:

- *Total number of independent assessment per fiscal year*
- *Total number of applications assessed per fiscal*
- *Number of application whose assessment score was below the funding call minimum quality threshold alluded to here: <https://www.gov.uk/guidance/innovation-apply-for-a-funding-award>*
- *Total spend on independent assessment per fiscal year*
- *Spend on assessing applications whose assessment score was below the funding call minimum quality threshold*

Our response:

I can confirm UK Research and Innovation (UKRI) hold the information relevant to your request. Please see the information below.

The spend figures below are rounded using a figure of £115 per assessment, as assessment fees vary from competition to competition. The majority are £120 per assessment, with most exceptions being a slightly lower value.

Assessor costs for business-led competitions have not been included as the assessments are voluntary and only a nominal fee of £1 per assessor is made.
