**Our response:**

I can confirm that UK Research and Innovation (UKRI) do not hold any information relevant to your request.

This report was produced as part of grant [ES/T014334/1](#)<sup>1</sup>, providing funding for the [ESRC Centre for the Microeconomic Analysis of Public Policy \(CPP\)](#)<sup>2</sup> which is hosted by the Institute for Fiscal Studies.
