Our response:

I can confirm that UK Research and Innovation (UKRI) holds some information relevant to your request. Please see the information below.

The projects selected for funding in the UK-Switzerland CR&D Round 2 competition were agreed in collaboration with [Innosuisse](#)¹. Each agency conducted their own assessments of projects submitted to their respective portals.

As per the [competition brief](#)², in order to be funded, projects had to be deemed successful by assessors of both agencies and funding was then awarded using a top-down approach, up to the cap of £4 million allocated to this competition. If a parallel application was unsuccessful in the corresponding Innosuisse programme, an application submitted to Innovate UK (IUK) could not be considered for funding, regardless of the score it received.

The information provided below is relevant to applications submitted to IUK only. Information is not held relating to applications submitted to and assessed by Innosuisse.
