Adkins bakery

As previously explained (FOI2023/00904) the BGS bakery contract was not extended or re-tendered. The new requirement was limited to 12 months, from January 2023, and was below £10k, therefore the procurement process allowed for the obtaining of a quote and a purchase order (PO) to be placed which covers 12 months. This was placed with Adkins. The PO has been extended by duration only (no increase in value) for a further 6 months.

Seasoned Events Ltd

This was a catering contract for an event on 30/11/2023 so no extension/replacement contract is required.
