**Freedom of Information request: FOI2024/00834**

Thank you for your Freedom of Information request received on the 17 September, and clarification received on the 24 October, in which you requested the following:

**Your original request:**

*I would like to request the information below:*

*The MRC welcomes good quality research on ME/CFS (Myalgic Encephalomyelitis) but few studies get funded.*

*What is the decision process of what studies get funded?*

*Who sits on the decision boards (names and positions)?*

*I would like this information to cover the years from 2010 to 2024.*

**Our clarification response:**

*Thank you for your Freedom of Information request, received 17 September, in which you requested information relating to ME/CFS (Myalgic Encephalomyelitis) funding.*

*In regard to the decision process of what studies get funded, information on an [overview of MRC review process](#)<sup>1</sup>, [what happens after you submit a proposal](#)<sup>2</sup> and [guidance for peer reviewers](#)<sup>3</sup> is already available online through the above links. We believe that information on what happens after a proposal is submitted may be particularly helpful.*

*It should also be noted that relevant applications could be submitted to any one of MRC's funding schemes, therefore there is not one specific decision board that is responsible for reviewing grant applications relating to ME/CFS.*

*Current membership of MRC research boards and panels is already available and published [here](#)<sup>4</sup>.*

*Given that membership of these panels is regularly changing, to provide historical membership data on every MRC board and panel dating back to 2010 would likely result in over 200 individual lists. Therefore, if there are particular boards or panels that you are interested in seeing this data for, please let us know.*

*We otherwise hope that the above information is sufficient to answer your request, but if you would like any additional information that may be held by MRC or UKRI, please can you clarify and confirm the information you wish to obtain.*

**Your amended request:**

*I understand that the 2010 to 2024 scope would mean too many studies and reviewers.*

Can I ask instead:

How many applications did the MRC get in the last 5 years for studies on ME/CFS (both successful and unsuccessful)?

What were the studies names and their authors?

Who were the reviewers?

Which studies were successful?

### Our response:

I can confirm that UK Research and Innovation (UKRI) holds information relevant to your request. Please see the information below.

Table 1 contains details of the number of grant applications received and projects funded by the Medical Research Council (MRC) relating to ME/CFS from 2020/21 to 2024/25.

We have determined that information relating to unsuccessful grant applications falls under Section 41 of the FOIA, information provided in confidence.

To explain further, applicants apply for funding with the knowledge that if successful their information will be published. It is therefore implied that applicants can confidently apply and information relating to their application will be kept confidential, unless they are successful. If the information was released, we believe it would result in an actionable breach of confidentiality.

Section 41 is an absolute exemption and does not require a public interest test.

As detailed in the [overview of the MRC review process](#)<sup>8</sup>, grant applications for MRC's responsive mode funding are initially peer reviewed by independent assessors and then assessed by a standing research board or panel.

The applications included in Table 1 above were all reviewed by either the Infections and Immunity Board (IIB) or the Population & Systems Medicine Board (PSMB), with the exception of two; one application in 2021/22 was reviewed by the Neurosciences and Mental Health Board (NMHB) and the 2020/21 funded project (MC\_PC\_20005) did not go through responsive mode funding, instead this was a commissioned study, co-funded by MRC and National Institute for Health and Care Research (NIHR). This was assessed by a bespoke panel of experts appointed by MRC and NIHR, along with a Patient and Public Involvement (PPI) representative.

Please note that not all board and panel members attend every meeting, therefore the information provided is on the standing membership of each board and not the individuals who assessed each individual application.

We are exempting the names of the independent assessors that conducted initial peer reviews of responsive mode grants, and individuals involved in the assessment of the successful co-funded grant MC\_PC\_20005, under section 40(2) of the FOIA. Disclosing this information would contravene the first Data Protection Principle as defined under Section 86 of the Data Protection Act 2018 and Article 5 of UK General Data Protection Regulation (UK GDPR).

Section 40(2) is an absolute exemption and does not require a public interest test.

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review, explaining which elements of this decision you disagree with and why.
