I can confirm that UK Research and Innovation (UKRI) holds some information relevant to your request. Please see the information below.

Information related to Innovate UK's total operating expenditure is published in UKRI's [Annual Report and Accounts 2022/23](#)¹ and can be found at Note 2 on page 122. This provides information on total operating expenditure and a breakdown by expenditure on staff, purchase of goods and services, and depreciation and impairment charges.

As this information is in the public domain, we consider that Section 21 of the FOIA - Information already reasonably accessible, would apply and have provided the relevant link above. Section 21 is an absolute exemption which means that there is no requirement to conduct a public interest test.

Information for the breakdown under the other headings included in part (ii) of your request is provided in the table below. This data represents the funding awarded in financial year 2022/23 not the funding claimed as the full award may not be spent in financial year 2022/23 but may be spent in future periods.
