Our response:

I can confirm UK Research and Innovation (UKRI) hold the information relevant to your request. Please see the information below.

- 1. Number of applications initiated overall (including those that were not submitted)*

A total of 4500 applications were started, included those that were not submitted, for the August 2020 round. A total of 2707 applications were started, including those that were not submitted, for the November 2020 round.

- 2. Number of actual submissions overall (number officially submitted)*

There were 2183 applications submitted for the August 2020 round, 264 of these were ineligible. There were 1501 applications submitted for the November 2020 round, 202 of these were ineligible.

- 3. Number of Grants awarded overall*

There were 74 grants awarded overall for the August 2020 round. There were 73 grants awarded overall for the November 2020 round.

4. % Success Rate overall

Excluding ineligible applications, the overall success rate for the August 2020 round was 3.9% and for the November 2020 round the overall success rate was 5.6%.

11. Total IUK commitment of funds per round

As per the information published in the competition briefs for the [August 2020](#)¹ and [November 2020](#)², the total funding allocated for the Innovate UK Smart Grants: November 2020 competition is up to £25 million.

The exact figure is exempt from disclosure under Section 22(1) of the FOIA as it is intended for future publication. Section 22 is a qualified exemption meaning that it is subject to the public interest test.

UKRI understand that being transparent in regard to the total amount of funding provided is in the public interest. However, the data is still incomplete and we are of the view that releasing the information as it currently stands would be inaccurate, incomplete and misleading and thus not in the public interest.

To explain further, successful projects are required to complete various project set up steps, including providing Innovate UK with documentation, collaboration agreements and exploitation plans, as well as passing financial viability and eligibility checks in order to receive grant funding. Until these steps have been completed accurate total funding amounts cannot be confirmed.

Once these checks have been completed and the projects have moved past the setup phase and are live, their information, including total funding amount, will be published in the [Innovate UK Transparency Data](#)³.

We have therefore determined that the outcome of this test is that the public interest is insufficient to justify immediate disclosure. The exact date on when this information will be updated is dependent on when the projects complete the setup process.

Please note that while applicants are asked to select a research category for their proposal, this is not used in the decision-making process. Innovate UK Smart Grants competitions are funded on a “top down” basis, based on the score awarded by the independent assessors and split across two streams as it defined in the competition brief.
