Under Section 21 - Information already reasonably accessible, of the FOIA some of the information you have requested is already available in the public domain. Section 21 is an absolute exemption which means that there is no requirement to conduct a public interest test.

Please find attached the relevant data relating to all UKRI funded projects in response to the COVID-19 pandemic. The data can be filtered for project title, grant holder, lead organization, abstract, amount, start and end date and project ID. The information on this webpage also includes topic maps for research grants and innovation grants for business which provide information on the projects funded by topic where you will find information on funding related to vaccines.
