- \* Actual spend on this contract/framework (and any sub lots), from the start of the contract to the current date*
- \* Start date & duration of framework/contract?*
- \* Could you please provide a copy of the service/product specification given to all bidders for when this contract was last advertised?*
- \* Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?*
- \* Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed?*
- \* Who is the senior officer (outside of procurement) responsible for this contract?*

**Our response:**

I can confirm that UK Research and Innovation (UKRI) do not hold any information relevant to your request. Please see the information below.
