**Your request:**

*I'd like the following information under the freedom of information act please:*

*Details of how much money UKRI has awarded to UK universities under the UK's guarantee for money that has been won from Horizon Europe but which cannot be obtained from Horizon Europe due to Brexit (as detailed here: <https://www.ukri.org/apply-for-funding/horizon-europe/>).*

*I'd like this data broken down by amount, year of award and the institution it was awarded to please. IE – amounts per year for each institution that was given money under this route.*

*If this information already exists in a slightly different format at UKRI (e.g. a spreadsheet) then this might do instead, I'd be happy to discuss.*

**Clarification received: 27 February 2023**

*Thanks for your response – I'm very happy to have the information I requested for all institutions rather than specifically for universities.*

**Our response:**

I can confirm that UK Research and Innovation (UKRI) does hold information relevant to your request. Please see the information attached as document 'FOI2023/00085 Horizon Europe awards'.

**Notes about the data provided:**

- As per the clarified request, the information provided covers all organisation types, not just universities
- Data is accurate as of 21 February 2023
- The year of award is the proposed project start date and all funds for that project are allocated to that year, not profiled over the duration of the award
- Organisation names are as they have registered on our systems
