Our response:

I can confirm UK Research and Innovation (UKRI) hold the information relevant to your request. Please see the information below.

Both the EPSRC postdoctoral fellowship program and the EPSRC synthetic biology postdoctoral fellowship program are open and ongoing opportunities with a number of applications that are still in the assessment stage, as such additional figures are provided for context. All figures are taken from data available as of 14 November 2021.

EPSRC postdoctoral fellowship

A total of 80 applications have been received for this program, of which a final decision has been made on 29. Of these 29 applications that have received a final decision, 24 progressed to the prioritisation panel and 5 progressed to the interview stage, with 1 application being successful and received funding from EPSRC.

Of the remaining 51 applications that are still in progress, 49 are currently under initial review and 2 are awaiting a final decision.

The details of the successful application to date are as follows:

Total funding: £305,811.57

Research organisation hosting the successful applicant: Queen Mary University of London

Title of the funded project: Modular representation theory, Hilbert modular forms and the geometric Breuil-Mézard conjecture

EPSRC synthetic biology postdoctoral fellowship

A total of 7 applications have been received for this program, of which a final decision has been made on 3. Of these 3 applications that have received a final decision, 1 progressed to the prioritisation panel and 0 progressed to the interview stage. No applications have yet been successful and received funding from EPSRC.

Of the remaining 4 applications that are still in progress, 3 are currently under initial review and 1 is awaiting interview.
