Our response

I can confirm UK Research and Innovation (UKRI) hold some of the information relevant to your request. Please see the information below.

Under Section 21 of the FOIA - Information already reasonably accessible, some of the information you have requested is already available in the public domain in the [published notice](#)¹ for the contract. Section 21 is an absolute exemption which means that there is no requirement to conduct a public interest test.

Not applicable. As per the [published notice](#)², this is a direct award in accordance with [PCR2015 Regulation 32 \(5\) \(b\)](#).³ This means there was no advertisement of the requirement, so there were no suppliers applying or tender documentation.

- **Actual spend on this contract/framework (and any sub lots), from the start of the contract to the current date**

As per the published notice, the value of this contract is £37,400.

- **Start date & duration of contract/framework**

As per the published notice, the start date of this contract is 3 May 2021 and the end date is 30 November 2021.

- **Has an extension been agreed, if so, for how long?**

Not applicable.

- **Will the framework(s)/contract(s) be up for renewal, if so when?**

Not applicable.

- **Could you provide the tender documents for this contract?**

Not applicable. As per the published notice, this is a direct award in accordance with PCR2015 Regulation 32 (5) (b). This means there was no advertisement of the requirement, so there were no suppliers applying or tender documentation.

- **Who is the senior officer (outside of procurement) responsible for this contract?**

The name of the senior STFC official (outside of procurement) responsible for this contract has been withheld. We consider that this information constitutes personal data and falls under the exemption at section 40(2) of the FOI Act. Section 40(2) exempts personal information such as names of individuals from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would, amongst other things, contravene one of the data protection principles. Disclosing this information would contravene the first Data Protection Principle as defined under Section 86 of the Data Protection Act 2018 and Article 5 of the UK General Data Protection Regulation (UK GDPR).

Section 40(2) is an absolute exemption and does not require a public interest test.

- **Which DPS or Framework was used to procure this piece of work?**

Not applicable. As per the published notice, this is a direct award in accordance with PCR2015 Regulation 32 (5) (b).
