UKRI used a pre-existing route to market for this specific procurement, the Crown Commercial Services (CCS) G-Cloud 10 Framework Agreement (RM1557.10). This Framework was established by CCS; UKRI was not involved in the establishment of the Framework, therefore CCS would hold the information sought.
