Our response

I can confirm that UK Research and Innovation (UKRI) does hold information relevant to your request. Please see the information below.

As noted in our request for clarification on 4 May, data for Innovate UK is not held within UK SBS systems and is therefore excluded from this response.

There were 811 employees who logged "Industrial Action" under Attendance Management on UK SBS systems for 15 March 2023. This figure includes all employees from across seven Research Councils, Research England, and UKRI's Corporate Hub, but excludes Innovate UK.

The breakdown of employees who logged industrial action for the workplaces you have listed is provided in the table below. Please note that your list does not contain all UKRI workplace locations, therefore the total of the figures below will not match the figure provided above.
