Thank you for your Freedom of Information request received on the 29 July in which you requested the following:

Your request:

I would like to request the following details for the recent Bilateral and Cooperation 2024 grant rounds including:

- *UK-Switzerland Bilateral: Collaborative R&D Round*
- *UK-Germany Bilateral: Collaborative R&D*
- *UK-Taiwan CRD*
- *UK-South Korea CR&D*

For those competitions above, I would like to know:

- *The number of applications/entries per round*
- *The number of applications per industry/sector, if possible too*

Thank you in advance, and my most pressing request is for the number of applications per round.

Our response:

I can confirm that UK Research and Innovation (UKRI) holds some information relevant to your request.

Please see Table 1 for the number of applications per competition. Please note that the [UK-Germany Bilateral: Collaborative R&D Round 3](#)¹, [UK-Switzerland CR&D Round 2](#)² and [UK-Taiwan CRD 2024](#)³ competitions are still on-going and either the funders panel has yet to take place, or applicants have yet to be informed of decisions. We have also included the number of successful applications for the [UK-South Korea CR&D 2024](#)⁴ competition.
