**Our response**

I can confirm that UK Research and Innovation (UKRI) hold information relevant to your request. Please see the information below.

Under Section 21 – (Information already reasonably accessible) of the FOIA, some of the information requested is already available in the public domain:

- UKRI actively publishes our responses to FOI requests that are received on the UKRI FOI disclosure log which contains all published FOI requests from April 2018.
